Reporting to the Senior Vice President (SVP) of Finance at the site level and the Trinity Vice President (VP) of Revenue Excellence at the system level, the Director will be an accomplished financial expert in reimbursement strategies. S/he will possess strong strategic thinking and operational skills and possess a proven track record of successfully designing and developing financial systems and controls. The Director will be a seasoned manager whose expertise includes Cost Reporting, Accounts Receivables Reserving, Reimbursement Accounting and Revenue Budgeting. S/he will have prior experience building and guiding a team whose primary role will be the successful implementation of financial strategies put in place to meet the objectives and needs of LUHS and Trinity as it relates to all reimbursement activities.

The Director will ensure the delivery of high quality patient care specific to the age/development needs of the patient populations that spans the continuum of care and will assume responsibility for achieving a level of shared operational management between physicians and health care services by bringing together the resources necessary to continuously improve the overall delivery of services. He/she will be comfortable operating in an environment of ambiguity and complexity, but also an organization dedicated to their values and Magis (Jesuit) values.

Masters prepared, the next Director will be a mission driven individual with eight plus years of experience, who is currently working in a provider organization and who has the outlined scope of responsibilities under his or her remit. Being a CPA is preferred but not crucial, but critical is the understanding of the Illinois payment structure and the nuances of Medicaid and BCBS reimbursement methodologies. A working knowledge of both physician and hospital reimbursement is essential but, most important is the ability to contribute in a meaningful manner to the overall strategic and financial goals of LUHS and Trinity and become a valued member of the financial leadership team under the auspice of Dan Isacksen.
